
BRIEF HISTORY

The agency was founded by individuals who are experienced and knowledgeable in the field of Security Management. APL's workforce is capable of providing security and safety to its corporate and individual clients.




BRIEF HISTORY


These personnel were subjected to character check passed the neuropsychiatric and drug tests, possesses valid and authentic license to exercise security profession.





HIRING PROCESS

mandated under RA 5487 (Private Security Agency Law).

SECURITY PERSONNEL

The applicant will be asked to fill up an agency form. He will then be required the following documents. He/She is going to bring the original and photocopy of all documents

DOCUMENTS NEEDED

- High school or College Diploma
- License to exercise profession
- Pre-licensing training certificate
- Any document to prove that he had served and honorably discharged from AFP, PNP and/or finished the CMT or ROTC advance course which can substitute in lieu of a PLT.
- SSS & TIN ID numbers
- Two (2x2) ID pictures.

- Barangay Clearance
- PNP Clearance
- NBI Clearance
- Clearance from previous employer

SECURITY PERSONNEL

The applicant then undergoes screening to verify if he is:

- High school graduate
- College level or College graduate
- At least 21 years old and 5'7" in height No derogatory record



SECURITY PERSONNEL



The applicant is then referred to take up the Neuro Psychiatric Examination and Drug test. A staff officer of the Operations Department then interviews the applicant including checking of his uniform and other paraphernalia.

If the applicant passes the interview and the Neuro Psychiatric examination, he shall be referred to the Operations/Personnel Manager for final interview.



SECURITY PERSONNEL

Character and employment investigation is then conducted thru:

- Inquiry from the applicant's former employer/s
 Inquiry from PADPAO for any derogatory
 information
- Interview and verify of any of the listed references to check for the veracity if entries in the application forms.

TRAINING SCHOOL

OF THE HIRED SECURITY GUARDS

- Hired security personnel are trained under and continue training at PNP Accredited Security Training Centers.
- Hired security personnel are regularly undergoing periodic trainings supervised by APLSSC. Conducted by the Operations Dept. and Staffs who are trusted, authorized, trained and competent security professionals in different fields of discipline and degrees of education relevant to security industry operations.





TRAINING PLAN

Before we endorse the guard to our client, we check the appearance, prescribe uniform, basic security equipment and orient them the required performance standard duties and responsibilities, the rules and regulations of the valued client. In addition we also conducted the following training for the guards prior to their deployment to with:

- Fire prevention and control
- Theft & Robbery and Personnel and Property Movement Control




FINANCIAL BUFFER

SALARY CUT-OFF

FINANCIAL CAPABILITY

Salary of Personnel (SG/SO) are prepared and given every 15th and end of month. However, due to the rigorous time consuming/collating of daily time records coming from different posts/detachments and its subsequent processing for every period, the in-cashing of personnel salary thru ATM, are adjusted into the following scheme.

- 1-15th monthly salary can be received every after five (5) working days or on the 20th of the said month.
- End of the month salary can be received every after five (5) working days or on the 5th day of the succeeding month.




BANK PAYROLL FINANCIAL CAPABILITY
